## **TACKLING ANTI SOCIAL BEHAVIOUR IN OUR COMMUNITY**

Please find attached issue 17 of our six-monthly updates.

The updates inform you of the interventions used in your area and this one sets out those used between 1 October 2016 and 31 March 2017. I also attach details of the number of calls received by your Anti Social Behaviour team.

My last update informed you about Public Spaces Protection Orders and advised you on how you could check where these were in your parish. We have almost completed updates to all signage throughout the East Riding and the remaining signs will be updated by the end of May.

Our team has recently taken responsibility for the safe and sound grant scheme to help residents stay safe in their own home. This issue provides more information on the scheme, including how residents can apply.

## SAFE AND SOUND GRANT SCHEME

The Council has made £28,000 available in 2017/18 and a further £20,000 in the following two years to help our residents stay safe in their own homes. In order to receive assistance residents must be:

- Aged over 60 or disabled and
- A homeowner or private sector tenant / housing association tenant.

In addition everyone living at the property must not have a bank balance, when added together, of over £5,000 and an application must not have been made by the applicant in the last two years.

If the resident lives in a rented property they must have permission from their landlord. There are no deadlines for applications. Further information, including an application form and a landlord consent form can be found on:

The Council has entered into a contract with a local company to visit each successful applicant and carry out a professional home security survey and discuss with the residents what type of home security equipment will make them feel safer. Once agreed, this will be installed. The equipment available includes:
